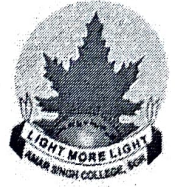

## Auction Notice

For and on behalf of Lieutenant Governor, Union Territory of Jammu & Kashmir, Principal Amar Singh College invites participation of registered dealers having GST- (Goods & Service Tax) and PAN (Permanent Account Number) for the sale of miscellaneous scrap articles on "as is where is" basis, lying at the Amar Singh College Srinagar through open auction.

The auction documents containing qualifying information, eligibility criteria, terms and conditions of auction and other relevant details can be seen/ downloaded from official website www.amarsinghcollege.ac.in or can be had from the office of the Principal Amar Singh College, Srinagar on working days during office hours.

1. **Cost of tender documents: Rs.590/- (Rupees Five Hundred and Ninety Only)** including GST, non-refundable, in the shape of Demand Daft or CDR pledged to Principal Amar Singh College payable at Srinagar (exemption in case of MSMEs on production of valid MSME Certificate).
2. **Earnest Money Deposit: Rs.6000/- (Rupees Six Thousand Only)**, refundable, in the shape of Demand Draft or CDR pledged to Principal Amar Singh College payable at Srinagar (exemption in case of MSMEs on production of valid MSME Certificate).
3. The bidders shall have to submit copies of all the necessary documents like CDR/Demand Draft, PAN, GSTIN, Registration Certificate (duly renewed), and authorization certificate.
4. The CDR and other documents should be submitted in the Office of Principal Amar Singh College Srinagar by or before **7<sup>th</sup> of February 2025 (4:00 pm.)**
5. The blacklisted firms shall not be considered for bid.
6. Principal Amar Singh College reserves the right to cancel the auction at any stage without assigning any reason thereof.

**Terms and Conditions**

1. The bid shall start from Rs.1,20,000/- (Rupees One Lac and Twenty Thousand) only including GST.
2. The intending bidders are requested to visit the Principal Amar Singh College, Srinagar, location of Scrap to be auctioned, on any working day during office hours for inspection/assessment of the scrap prior to the auction of the scrap.
3. The intending bidders shall have to deposit an earnest money in shape of CDR/Demand Draft to the tune of Rs. 6,000/- pledged to the Principal Amar Singh College, Srinagar payable at Srinagar by or before 07-02-2025 (4:00 pm) as security deposit.
4. No agency shall be allowed to participate in the auction without depositing earnest money.
5. The security deposit of the bidders shall be released after one week from the date of auction.
6. Bids shall be offered in open in presence of the auction committee and all bidders.
7. No bid shall be entertained through telephonic or any other way.
8. The undersigned reserves the right to cancel, with or without assigning any reason, one or all bids.
9. The successful bidder shall have to deposit 50% payment by or before 10.02.2025.
10. The successful bidder shall have to deposit the remaining 50% amount within 3 working days from the date of the auction.
11. The successful bidder(s) shall have to complete the work within **five days** from the date of allotment of order, failing which the amount deposited shall be forfeited and stuff shall be re-auctioned without serving any notice to the successful bidder. Extension in a time frame claim, from purchaser, as matter of right, shall not be entertained. However, Principal Amar Singh College may consider the request for extension in time frame in case the circumstances warrant so.
12. Any stock left at the site at the end of the working period shall be treated as property of Principal Amar Singh College and shall be disposed off accordingly for which no compensation claim shall be entertained.
13. Intended bidders can visit office of the Principal Amar Singh College for any query or information.
14. In case of any dispute between Principal Amar Singh College and successful bidder, the decision of the Principal Amar Singh College shall be final and binding upon all.
15. The bidder shall have to remove all the material above the ground within stipulated time frame.
16. Any loss to any property caused due to lifting of the scrap shall be borne by the bidder/purchaser.
17. The successful bidder shall have to produce following documents
  - Profile of the firm indicating names of its proprietor's/ Partners.
  - Self-attested copy of PAN Card under I.T Act.
  - Proof of registration of the firm with the Government.
  - GST Registration no.
