PUBLIC NOTICE

1. Whereas, Amar Singh College Srinagar has canteen facilities within the campus for students, faculty and non-teaching staff members and the canteen services are run by experienced service providers qualified through invitation of bids on GeM portal on annual basis.
2. Whereas, tendering was initiated with a bid document No. **GEM/2024/B/5571381**, dated **04/11/2024**, whereby bids were invited for Canteen Service- in the college. After conducting the tendering process, the bidder/seller named **Shrunz Fall** was declared as **L1 Bidder** having the lowest price quoted from all other participants.
3. Whereas, the canteen committee after the analysis of the rate of items submitted by the **L1 Bidder** namely; **Shrunz Fall** noted that the rate of the significant number of '*items highlighted are unrealistic/unjustified as per the market rates*' and recommended for the re-tendering through the GeM portal. The proposal of the canteen committee was approved by the Principal and as proposed, approval was granted for re-tendering through GeM portal.
4. Whereas, the re-tendering proceeded as per the rules. A bid document No. **GEM/2024/B/5893439**, dated **31/01/2025**, whereby bids were invited for Canteen Service of the college. After conducting the tendering process, the bidder/seller named **Aadil Enterprises (the petitioner)** was declared as **L1 Bidder** having the lowest price quoted from all other participants.
5. Whereas, the canteen committee after the examination of the rate of items submitted by the **L1 Bidder**, **Aadil Enterprises** noted that '*the rates provided were not in line with the market standards and were impractical for both cost management and quality delivery of items and are unrealistic/unjustified as per the market rates*'.
6. Whereas, the tendering process has been conducted in accordance with the **Terms and Conditions** for running the College Canteen at Amar Singh College, Srinagar, as issued by the Competent Authority of the college and available on the GeM portal wherein under point 42 (Annexure A), it is specifically mentioned:

"The undersigned reserves the right to reject or cancel any tender or all tenders without assigning any reason thereof.

7. Whereas, *in view of the unrealistic/unjustified rates as per the market rates*' provided by the L1 bidder and analysis of the rates by other bidders, the canteen committee has recommended the e-tendering should be done on the basis of a fixed monthly rent.
8. In view of the above facts, it is decided to cancel the tender and not proceed further in finalising the tender/bid process by issuing any allotment order.
